### **CLASS TITLE: SPEECH-LANGUAGE PATHOLOGY ASSISTANT (Range 30)**

#### **BASIC FUNCTION:**

Under the direction of a Licensed Speech-Language Pathologist, assists in providing speech therapy services to special education students in accordance with Individualized Education Program (IEP); maintains records and documentation on students; and performs related duties as required.

#### **REPRESENTATIVE DUTIES:**

Provide speech therapy services according to Individualized Education Program (IEP) goals developed by a Speech-Language Pathologist in accordance with District policies and procedures. *E*

Assist Speech-Language Pathologist during assessment. *E*

Gather data in the educational environment in such areas as oral motor skills, intelligibility, language function and usage. *E*

Prepare therapy materials and/or equipment for use in classroom and therapy activities. *E*

Adapt or modify instructional materials and/or equipment as determined by student needs and abilities for teacher use in classroom. *E*

Document student progress; assist with informal documentation. *E*

Schedule activities; prepare charts, records, graphs or otherwise display student performance data. *E*

Prepare checks and maintenance on augmentative communication devices and equipment. *E*

Schedule IEPT meetings, assessments and otherwise assist Speech-Language Pathologist in preparation of student information for presentation to parents, staff, etc. *E*

Participate and collaborate as a member of an educational team in developing and providing services for individual students to improve their academic performance. *E*

Participate in research projects, in-service training and public relations programs. *E*

Works in an itinerate capacity at multiple sites. *E*

Perform other related duties as assigned.
