An updated résumé and current letters of recommendation are optional. 4. The Personnel Department will mail the <u>Interest List</u> to the school site(s)/department(s) and selected applicants will be notified to appear for an interview.

After a conditional offer of employment, applicants will be required to pay the cost of all pre-employment processing which may include: physical examinations, drug/alcohol screening, TB screening questionnaire and fingerprints. Additionally applicants will be required to complete/participate in the following: AB1432 Mandated Reporting training, Safety training, and Technology Acceptable Use.
